OUR FRATERNITY: ON TRACK FOR THE FUTURE

Dear Brothers:

With the first half of the biennium completed and the second half well underway, our fraternity is continuing to successfully develop and initiate many new programs. This past year we completed the Summer Leadership Schools and now the fall Regional Conferences are completed. Let's highlight, briefly, these two programs and also update our progress on completing our major goals for the biennium.

This past summer, 12 of 17 regions participated in our first Summer Leadership Schools. This summer program aimed at developing and improving the fraternal and individual leadership skills specifically for our national officers. Approximately 70% of all of our national officers, particularly District Directors, participated in the program. No other fraternal function has ever attracted such high numbers of national officers. An added highlight of the program was the presentation of a video tape spe-

cifically prepared for the Delta Sigma Pi Summer Leadership School program. This video program was developed in cooperation with WOSU-TV in Columbus, Ohio. In our fraternity, we have begun merging our activities with corporate America. We are already making plans for our next Leadership School in August, 1988.

The months of September and October saw our most successful Regional Conferences ever held! Across the country our Regional Directors met the needs of our collegiate and alumni members alike! Not only did our Regional Conferences offer educational "core programs" for collegiates such as Recruiting, CEI as a Management Tool, Pledge Education, etc., but much more! Most Regional Conferences began offering some of our new collegiate Leadership School topics such as: Graduate School Planning and Improving Communication and Leadership Skills.

The South Pacific and East Central Regions sponsored "job fairs" where corporations were allowed to present their firms to our collegians. Also, over 40% of our Regional Conferences began offering alumni programming and activities. This is outstanding and unprecedented in our fraternity!

Our Regional Conferences also addresses our fraternity's strong new stand on alcohol and substance abuse and initiation and hazing problems. This new stand was well received and applauded by our membership.

Finally, with the conclusion of our National Executive Committee meeting in Cincinnati in August, our fraternity is rapidly closing in on our goals we established for the 1985-87 biennium. Although I will outline these programs in more detail in the next issue of The DELTA-SIG, allow me to briefly highlight them now. Our national committee program structure and the role of the Provincial Vice Presidents is being completed and finalized. Our Career Placement and Planning program, Director of Development program, our commitment to improving alumni benefits and services and our fraternity's 10 year long range plans are continuing to be developed on schedule. In fact, the goal for our next National Executive Committee meeting in February, 1987, is to finalize our national biennial goals.

In Delta Sigma Pi—we strive to be the BEST! We continue to affirm to our membership that your experience in our fraternity will be unmatched in your career endeavors!

THIRTY YEARS IN OXFORD

Thirty years ago this fall, The Central Office first opened its doors for business at 330 South Campus Avenue in Oxford, Ohio. The fraternity remembers and salutes those who have made it all possible.

This fall marks the 79th Anniversary of Delta Sigma Pi's founding at New York University. Delta Sigma Pi has become one of the premiere professional collegiate fraternities in the world, enjoying a rich heritage. Its history includes many great moments and recognizes many great men and women in the commercial and academic world. Paralleling the history of the fraternity is the creation and development of its national headquarters, The Central Office. This fall marks the 30th Anniversary of the move of The Central Office from 222 West Adams Street in Chicago to 330 South Campus Avenue in Oxford, Ohio.

Since the doors of The Central Office were opened in Oxford on September 1, 1956, many men and women have dedicated part or all of their careers to the service of Delta Sigma Pi at The Central Office. For some, working at The Central Office has been just the start of a career that has taken them to other parts of the country. For these people,

working at The Central Office may have just been a one to two year stop in their lives filled with unforgettable memories about working for the fraternity. For others, Oxford has become a permanent home, even after leaving the employ of the fraternity at The Central Office. Still for others, working at The Central Office has served to provide the opportunity, over several years of employment, to develop a professional foundation which has continued elsewhere in the business world. In all cases, working for the national headquarters of Delta Sigma Pi has provided the past and present employees of The Central Office with many exciting, challenging, rewarding and sometimes, frustrating moments which cannot be experienced in any other line of work.

Elsewhere in this issue is an article introducing you to the individuals who currently work for the national fraternity at The Central Office. In addition to presenting them to you, some highlights of The Central Office and its 30 year history in Oxford are presented here.

Although the idea of Delta Sigma Pi having its own Central Office Building rather than leasing office space was in existence for many years, little was done about it until 1949 when then Grand President Allen L. Fowler persuaded the Grand Council to create a Central Office Building Reserve Fund for

the eventual construction of such a building. This Fund grew slowly with small appropriations being made each year from the general operations of the fraternity.

In 1954, the thought of a Central Office Building sprung to life when the Grand Council was seeking some suitable way to recognize H. G. Wright, who had served as Executive Director and Administrator of The Central Office for some 30 years, and who anticipated retirement in 1955. The decision was made in the

summer of 1954 to proceed with the construction of a building after an investigation had proven that it was feasible and desirable. The next year was a busy one, with the creation of enabling legislation, the search for a suitable location, the campaign for funds and the development of construction plans.

Ground breaking ceremonies for the new Central Office took place in September, 1955. A very severe winter handicapped the builders for several months, pushing back the proposed completion date from May, 1956, to September 1, 1956. Finally, though, the cornerstone was laid on August 24, 1956, and ceremonies were conducted by Grand President J. Harry Feltham officiating and the date for occupancy of the new Central Office was set for September 1, 1956. A description of the move of The Central office from Chicago to Oxford was best recorded in the report of Executive Director James D. Thomson, presented at the 21st Grand Chapter Congress in 1957. Part of that report is reproduced here:

“In May of '56 when we were supposed to move in, giving us a whole summer to unpack our gear and practice a little for the benefit of the entirely new staff, the building was at the stage where it resembled a roofless barn with only the walls standing. It was then that our opti-

mism showed for a second time because we began to pack and boldly announced that come 'hell or high water' we intended to move to Oxford on September 1. I'm sure the contractor, architects and everyone else concerned was laughing at us for being so naive as to think that the building could possibly be ready for us on that date, but they humored us by not expressing their thoughts. Instead, extra crews of men were employed, and Saturday, Sunday and holiday schedules were adopted in order to make our wishful thinking a reality if at all possible. What a headache our optimism must have been to them? We may never know.

Came September 1, 1956, we turned the key in the door at 222 West Adams Street for the last time, after overloading a Mayflower van by 15,000 pounds, and gaily set out for Oxford. Our spirit was soon badly bent, for the building was not ready to receive us. Tarpaulins for doors, planks for stairs, extension cords for illumination and make-shift plumbing greeted us. I don't think I'll ever forget the look on the van driver's face when he pulled up in front and I assured him that he had the right place. 'Got to humor this crazy man,' he thought, 'he could be dangerous.' Four carpenters and a little ingenuity built the best ramp you ever saw, from the van to the first floor permitting all

of our desks and other equipment to be placed in the center of the three rooms slated for early completion. About 150 cartons of supplies were dumped on cement blocks in what is now our basement meeting room. All the while the unloading progressed, the painters, carpenters, electricians and plumbers continued to whittle away at the job around them stopping only long enough to dodge a desk or a file coming their way. You have no doubt seen or at least heard of the three ring circus, believe me this had it beat and the pounding lasted for several months, too.

One week after the movers departed the painters collected their buckets from three-fourths of the first floor which permitted us to descend with brooms, mops, rags and vacuums. It took one solid weekend to dent the dirt and dust that had accumulated on our equipment and to shift it around so that it could be put to use. We thought then that we had it licked and that we could begin to provide the service being demanded by the men returning to the campuses. Wham, the bubble burst again when our brand new staff was driven out of the building repeatedly by power failure, cold days and no heat. When I look back I sure admire the spunk of our new staff which moved desks, scrubbed equipment and turned out work under every conceivable hardship.

By November we had thoroughly convinced everyone that we were as stubborn as Missouri mules and that we were determined to stay. Each day, too, made better Greeks out of the staff and they no longer ran for cover when we shouted mail those Form J's to Gamma Delta and tell Alpha Lambda the badges are coming from Burr, Patt. An occasional shout in the direction of the carpenters and painters had its effect, too, and by February they had retreated out the back door leaving a completed building in their wake. And, thus, The Central Office moved from Chicago to Oxford, a rugged experience which I don't believe I could face again, but one which had its humorous side and one which certainly produced a great deal of satisfaction.

Was it worth it, you be the judge. Picture if you will a fine substantial colonial building standing stately on an acre of ground with new lawns neatly manicured and young shrubs and trees straining to play their part in the overall picture. Across the street and up the block stretches the beautiful Georgian campus of Miami University. 'Ivy league' all the way. Better yet, a whole town of strictly college and The Central Office of Delta Sigma Pi is an integral part of it, taking its place alongside the national headquarters of Beta Theta Pi, Phi Delta Theta and Phi Kappa Tau."

After the move was completed, The Central Office of Delta Sigma Pi at 330 South Campus Avenue in Oxford, Ohio, was finally dedicated to Brother H. G. "Gig" Wright on May 18, 1957.

The move to Oxford necessitated the hiring of a complete new staff with the exception of Executive Director Jim Thomson and Executive Secretary Ray Flodin, both of whom moved to Oxford from Chicago. Through the years, members of the staff of The Central Office have changed just as has the fraternity. Since The Central Office was completed in 1956, Delta Sigma Pi has grown from 94 chapters to 215 chapters. In 1956, total membership of the fraternity was 37,000 as compared to a membership in excess of 127,000 today. To keep pace with this dramatic increase in the size of the fraternity over the past 30 years, many changes have been made to keep pace with the level of service that the membership has come to expect.

In 1959, the Field Secretary program was inaugurated at The Central Office. This program, which continues today as the Chapter Consultant program, allows The Central Office to visit almost every chapter

Delta Sigma Pi enjoyed a successful year as the fraternity welcomed back Iota Chapter at the University of Kansas and new chapters at Grand Valley State College, Western Illinois University, the University of San Diego and Livingston University.

The 1985-86 academic year proved to be a very productive one in the area of expansion of the fraternity. During the second semester of the 1985-86 academic year, Delta Sigma Pi installed four new chapters and reactivated one. The chapters installed were: Lambda Xi Chapter at Grand Valley State College; Lambda Omicron Chapter at Western Illinois University; Lambda Pi Chapter at the University of San Diego; and Lambda Rho Chapter at Livingston University. After an absence of approximately 10 years, the fraternity's ninth chapter, Iota Chapter at the University of Kansas, was reactivated. These chapters have joined the Delta Sigma Pi family and continue to represent the fraternity well at their respective campuses.

"It is with great pleasure that I introduce Grand President John V. Henik to present the Iota Chapter

Charter to our newly initiated Brothers at the University of Kansas. Brother Albert Greiff, a charter member of Iota Chapter and the winner of the first Delta Sigma Pi Scholarship Key awarded at the University of Kansas in 1920, will assist in the presentation."

With these words, Midwestern Regional Director Marlow B. Kee concluded the fraternity's efforts to reactivate Iota Chapter at the University of Kansas. Originally founded in 1920, the chapter became inactive during the mid-1970's. Efforts to reactivate Iota Chapter began in the spring of 1985 when Brother Joseph L. Goldblatt, an alumnus of Delta Upsilon Chapter, relocated to Lawrence, Kansas. Approval was received from university administrators during the summer of 1985 and plans were made to recruit future Deltasigs beginning in the fall semester.

Three recruiting activities were conducted in October of 1985 with over 50 students at the University of Kansas expressing an interest in reactivating Iota Chapter. Mid-American Provincial Vice President Randy Hultz, along with members of Kappa Omicron Chapter at Southwest Missouri State University, visited the Kansas campus to assist in the recruiting efforts. Colony meetings were conducted throughout the fall semester as were several profes-

sional and community service activities. Colony members selected the name of Nu Iota to reflect that the colony would become the revitalized Iota Chapter of Delta Sigma Pi.

Additional recruiting activities were conducted during the spring semester and the professional and community service calendar were broadened to include more events. Colony members participated in a range of fund raising activities to

offset the cost associated with the reactivation banquet. A pledging ceremony was conducted in February, 1986, and a pledge education program was begun immediately thereafter.

The members of Nu Iota Colony received regular visits from Midwestern Regional Director Marlow B. Kee, District Director Joseph L. Goldblatt, Mid-American Provincial Vice President Randy L. Hultz and members of the Kansas City Alumni Chapter. During the reactivation process, alumni Brothers Cindy Prier and Tim Turns were extremely helpful in conducting the pledge education program. Brothers Prier and Turns later received Testimonials of Appreciation from the fraternity for their efforts in reactivating the chapter. Daily support and assistance was also provided to the chapter by Brother Joseph Goldblatt who received an award from the colony and a Board Testimonial of Appreciation to recognize his exemplary efforts.

With the pledge education program complete, a professional calendar developed and implemented, a solid financial base and a well rounded calendar of social activities developed, the members of Nu Iota Chapter submitted a letter to the fraternity's Central Office requesting that they be initiated as mem-

bers of Delta Sigma Pi. The Board of Directors approved this reactivation and on April 19, 1986, 35 members of Nu Iota Colony became Brothers in Delta Sigma Pi.

Members of Delta Chi Chapter at Washburn University, Iota Omicron Chapter at Central Missouri State University, and Kappa Omicron Chapter at Southwest Missouri State University served on the Ritual Team for the installation of the 35 new members of Iota Chapter. The intallation team also included Grand President John V. Henik, Past Grand President and Western Provincial Vice President William W. Tatum, Jr., Mid-American Provincial Vice President, Randy L. Hultz, Midwestern Regional Director Marlow B. Kee, Intermountain Regional Director Charles E. Farrow, Director of Chapter Services C. Dean Ferguson and District Directors Larry Lunsford and Joseph Goldblatt.

The new Brothers of Iota Chapter celebrated their reactivation with a banquet the evening of April 19th at the Alvarado Country Club. The Catfish Swing Band provided the evening's entertainment. The evening was highlighted by the return of the original Iota Chapter Charter to Chapter President Joe Hattesoil. The evening's guests were also pleased to celebrate the birthday of Past Grand President William W. Tatum, Jr. The newly initiated Brothers of Iota Chapter were also pleased to welcome to the reactivation banquet Dr. Albert Grief, a former Marine Corps Aviator and a charter member of Iota Chapter. The evening concluded as the members of Iota Chapter celebrated with other Deltasigs from across the country, the reactivation of the fraternity's ninth chapter.

LAMBDA XI CHAPTER INSTALLED AT GRAND VALLEY STATE

Lambda Xi Chapter was officially installed on Saturday, April 19, 1986, on the campus of Grand Valley State College in Allendale, Michigan. The fraternity's 212th collegiate chapter, and the ninth chapter founded in the state of Michigan, Lambda Xi Chapter is located in the

Central Region in the Northern Province.

The beginnings of Lambda Xi Chapter began a few years ago in 1982 when alumni Brother Scott Kanig expressed an interest in forming a chapter of Delta Sigma Pi at Grand Valley State College. The administration of the college did not feel that the 1982-83 academic year was an appropriate time to begin expansion efforts, but initial recruiting efforts finally began during the fall, 1984, semester. By the end of the 1984-85 academic year, a group

of eight students were committed to forming a Delta Sigma Pi chapter. Officers were elected at the conclusion of the 1985 spring semester and two of these officers attended the Grand Chapter Congress in Dallas, Texas, during the summer.

Recruiting efforts were implemented during the fall, 1985, semester, along with an ambitious program of professional activities and fund raising projects. The colony took the name, Gamma Phi Sigma, and continued to plan a wide range of colony activities. Assistant Executive Direc-

tor Michael T. Walsh visited the colony during October and provided the colony members with additional information on chapter programming and how to establish a chapter of Delta Sigma Pi. The members of the Western Michigan Alumni Chapter, including District Director Michael E. Melinn, were regularly present to aid in the colony during their formative stages.

Director of Chapter Services C. Dean Ferguson conducted a follow-up visit with the colony in January, 1986, and on February 25, 1986, the members of Gamma Phi Sigma Colony were pledged into Delta Sigma Pi. Members of the Western Michigan Alumni Chapter, along with District Director Mike Melinn, conducted the pledge education program.

In March, 1986, Gamma Phi Sigma Colony submitted its petition to the Board of Directors requesting that it be granted a chapter charter in Delta Sigma Pi. The Board of Directors approved the petition on March 24, 1986, and the installation of Lambda Xi Chapter took place on

the campus of Grand Valley State College on Saturday, April 1986.

Serving on the Installation Team were: Northern Provincial Vice President Thomas E. Sheely; Central Regional Director James P. Higgins; District Director Michael E. Melinn; Golden Council member Anthony Z. Fernandez; Assistant Executive Director Michael T. Walsh; and members of Delta Rho Chapter at Ferris State College, Iota Lambda Chapter at Indiana University-Purdue University at Ft. Wayne, Kappa Phi Chapter at Valparaiso University and the Western Michigan Alumni Chapter. The initiation of the Lambda Xi Chapter members took place in Lake Huron Hall on the Grand Valley State College campus.

Later in the evening, the Installation Banquet took place at the President Inn in Grand Rapids, Michigan. The Invocation was offered by J. Bradley Duhe, Epsilon Nu Chapter President at the University of New Orleans. The Toastmaster for the evening was Central Regional Director James P. Higgins. Eric R. Hamilton, Chancellor of Lambda Xi Chapter, extended Greetings to all guests and members in attendance at the Ban-

Collegiate chapter members were present from Phi Chapter at the University of Southern California, Delta Sigma Chapter at Loyola Marymount University, Gamma Psi Chapter at the University of Arizona, Gamma Omega Chapter at Arizona State University, Zeta Omega Chapter at Northern Arizona University, Iota Pi Chapter at San Diego State University and Iota Upsilon Chapter at California State University-Northridge. The list of national fraternity officers in attendance was similarly lengthy and began with Grand President John V. Henik, Director of Alumni Activities Joe S. "Skip" Loomis, Western Provincial Vice President William W. Tatum, Jr., South Pacific Regional Director William R. Kinsella, Intermountain Regional Director Charles E. Farrow, Western Regional Director Claire S. Roberts, Director of Chapter Services C. Dean Ferguson and District Directors Tani Chartier, Paul J. P. Garcia, Stephen L. Rop-

fogel, Wendy J. Worchester and Brian K. Judd.

The installation banquet at the Hyatt Ilandia in San Diego culminated an 18 months effort to start a chapter at the University of San Diego. Members of Iota Pi Chapter at San Diego State University first explored the possibility of establishing a chapter at the University of San Diego during the 1984-85 academic year. The chapter members received approval from Dean James M. Burns of the School of Business Administration to begin recruiting efforts in the fall semester of 1985. Members of Iota Pi Chapter manned recruiting events and were surprised to learn that Brother Scott Morey, an initiate of Zeta Omega Chapter at Northern Arizona University, was attending the University of San Diego. Brother Morey became a focal point for the colony and served for several months as the colony President. Once the chapter was installed, Brother Morey became its first chapter President.

From a core group of 19 members during the fall semester, the colony membership grew rapidly during the first few weeks of the 1986 spring semester. The colony members selected the colony name of Beta Theta Beta reflecting the members desire to have Brotherhood through business. The colony members developed a calendar of

activities for the two semesters which included numerous professional speakers and tours, community service projects, university service projects and fund raising activities. The progress of the colony was rapid and the members were ready for a pledge education program in early March. In March 1986, a pledging ceremony was conducted by South Pacific Regional Director William Kinsella and District Director Tani Chartier. The colony members of Beta Theta Beta then completed an eight week pledge education program under the guidance and tutelage of District Director Chartier, members of Iota Pi Chapter and the colony's elected Vice President for Pledge Education.

Delta Sigma Pi welcomes the 51 newest members of Lambda Pi Chapter into our Brotherhood.

LAMBDA RHO CHAPTER INSTALLED AT LIVINGSTON

Beginning in 1977, a group of students in an organization known as the Owen Love Business Association operating on the campus of Livingston University expressed an interest in becoming a part of the International Fraternity of Delta Sigma Pi. During the course of the initial inquiry, it was determined that the enrollment in the College of Business and Commerce at this institution was far too small to adequately support a chapter of the fraternity. Since that time, enrollment at this institution has drastically increased and on Saturday, May 17, 1986, what was then known as the Lambda Beta Alpha Fraternity was installed as Lambda Rho Chapter of the International Fraternity of Delta Sigma Pi.

In early 1985, Ms. Katie Kemp contacted The Central Office of Delta Sigma Pi for further information concerning the establishment of a chapter at Livingston University. Shortly thereafter, the Owen Love Business Association became the Lambda Beta Alpha Colony of Delta Sigma Pi. Both Ms. Kemp and colony President Keith Crawford attended the 35th Grand Chapter Congress held in Dallas, Texas, later that year.



The Lambda Rho Chapter Charter was presented to chapter president Lynette Youngblood by Southern Provincial Vice President Charles F. Eaton, Jr. and the Dean at Livingston University.

A full calendar of activities had been conducted by the Lambda Beta Alpha Colony and its predecessor organization for many years. These activities intensified when it became a colony of Delta Sigma Pi.

In early May of 1986, the Board of Directors of the International Fraternity of Delta Sigma Pi voted affirmatively to grant a charter to this, the fourth chapter founded in the state of Alabama.

Installation weekend began with an informal social event held at the

home of Dr. Donald C. Hines *Troy State*, Dean of the College of Business and Commerce. On the morning of May 17, 1986, Deltasigs from Gamma Tau Chapter at the University of Southern Mississippi in Hattiesburg gathered for the installation of Lambda Rho Chapter. Southern Provincial Vice President Charles F. Eaton, Jr., served as Headmaster for the Ritual Team and was assisted by Southern Regional Director James F. Pendergrass, Southeastern Regional Director Velvet A. Mitchell, Execu-

tive Director Michael J. Mazur, Jr., and Chapter Consultant Mitchell B. Simmons.

Following the initiation ceremonies, the 41 collegiate members and the two faculty members constituting the charter membership of Lambda Rho Chapter gathered along with the attending national officers, faculty of Livingston University and the members from Gamma Tau Chapter gathered for the installation banquet. The Invocation was delivered by Vice President for Pledge Education Michael Stuart, and Greetings from Livingston University were delivered by Katie J. Kemp of the College of Business and Commerce.

A History of the College of Business and Commerce was delivered by Dean Donald C. Hines and a history of the Lambda Beta Alpha Fraternity was delivered by Kelli F. Kiker, Historian of Lambda Rho Chapter.

The highlight of this exciting weekend in Livingston, Alabama, came when the charge and charter of Lambda Rho Chapter was presented by Charles F. Eaton, Jr., to Lynette Youngblood, president of our newest chapter.

Started on a foundation of continuous strength and organization of a period expanding nearly 10 years, we welcome the Brothers of Lambda Rho Chapter into Delta Sigma Pi as they begin their existence as a chapter of an International Fraternity on the campus at Livingston University.

During his days at the Georgia Institute of Technology, Howard served Kappa Chapter as President and Headmaster.

On April 29, 1986, Howard Bergstrom Johnson, 16th Grand President of the International Fraternity of Delta Sigma Pi, passed away at age 73. Initiated in 1931 at Kappa Chapter, which was then located at the Georgia Institute of Technology, Brother Johnson served his chapter as President and later served as a Province Officer. In 1936, he served as general chairman for the 12th Grand Chapter Congress held in Atlanta, Georgia.

Born in Tallapoosa, Georgia, in 1912, he graduated cum laude from Georgia Tech in 1934. He was employed by the Atlantic Steel Company in Atlanta for 37 years where he served as Vice President, President and Chairman of the Board. Brother Johnson was a former director of the American Iron and Steel Institute, the Atlanta Chamber of Commerce and the Atlanta Rotary Club.

He also served as a member of the advisory board of Clark College.

In the early 1970's he developed Parkinson's disease and remained in a convalescent center until his death. Despite his health problems, Brother Johnson delighted in having Deltasigs, both young and old, visit him to share memories of his beloved fraternity and to hear about its continuing progress.

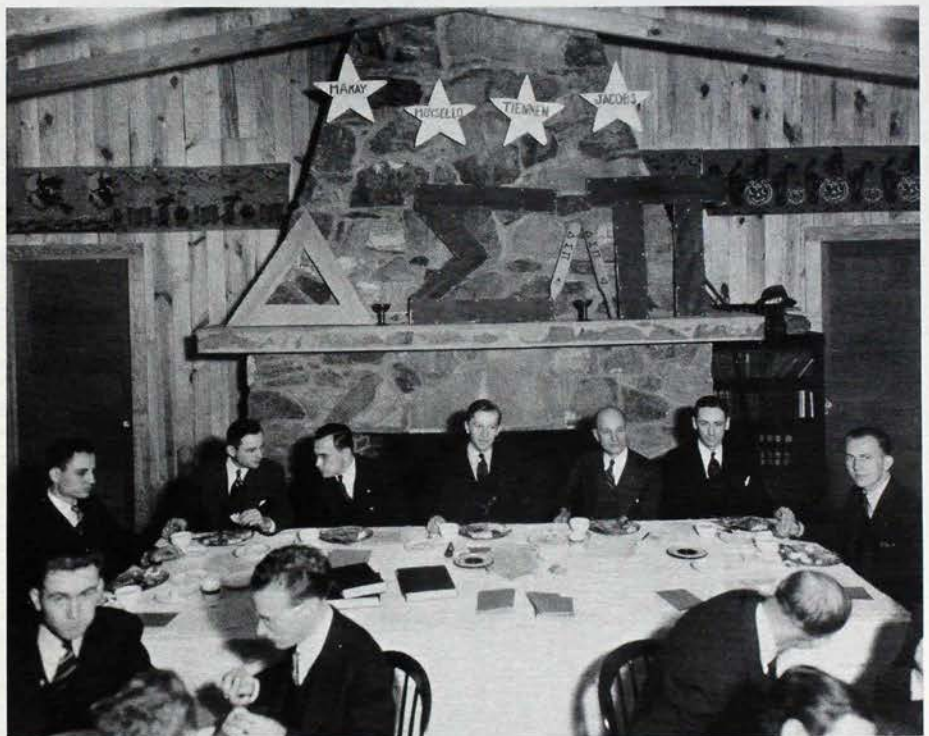

SERVING YOU FROM OXFORD

Presenting members of the staff

It has been a little more than two and a half years since we presented The Central Office staff to you in The DELTASIG, so we wanted to reintroduce you to many of the people who work at your fraternity's headquarters. We also want to introduce you to the people who have joined the staff since we last featured them in The DELTASIG. There have been several personnel changes and changes in responsibilities in the staff at The Central Office, so this introduction should bring you up-to-date about the people who work for you.

The Central Office is located in the small college town of Oxford, Ohio, which is located in southwestern Ohio, roughly 35 miles northwest of Cincinnati. The surrounding areas are primarily rural, but the town itself serves as the home of Miami University, founded in 1809. "Mother of Fraternities", is a title often placed on Miami since Beta Theta Pi, Phi Delta Theta, Phi Kappa Tau and Sigma Chi fraternities were all founded there. In addition, Delta Zeta sorority was also founded at Miami. Today, Beta Theta Pi, Phi Delta Theta, Phi Kappa Tau and Delta Zeta all maintain their national headquarters in Oxford.

The Central Office is adjacent to the Miami campus. The building, which was built in 1955 and 1956,

the fraternity is their career. National officers are not paid other than for partial reimbursement for expenses which they incur as volunteers.

Now, let's meet the members of The Central Office staff in Oxford . . .

Executive Director **Michael J. Mazur, Jr.**, is the chief operating officer of the fraternity and is responsible for the operations of The Central Office and for the administration of the national programs of the fraternity. His duties are widely diverse and include personnel, convention and meeting planning, financial administration and public relations. In addition, he is the Editor of The DELTASIG and other official publications of the national fraternity. He represents the fraternity in several fraternal and

and expanded in 1970, is designed after the Raleigh Tavern in Williamsburg, Virginia, where many of the meetings of Phi Beta Kappa, the first fraternity, were conducted. The Central Office serves Delta Sigma Pi, not only as its service center, but also as the fraternity's archives and museum.

The members of The Central Office staff are employees of the fraternity. National officers of the fraternity, including members of the Board of Directors and District Directors, are employed in diverse occupations throughout the country and devote their leisure time to perform volunteer work for Delta Sigma Pi. Central Office staff members are salaried and

Mike resides near Oxford and is a member of the Oxford Jaycees.

Assistant Executive Director **Michael T. Walsh** manages the day-to-day operations of many of the administrative functions of The Central Office staff including chapter accounting, secretarial services, purchasing and maintenance. Mike is also responsible for the development of most official publications. He is the Managing Editor of The DELTASIG Magazine and is involved in the detailed operations of developing and assembling this official publication of the fraternity.

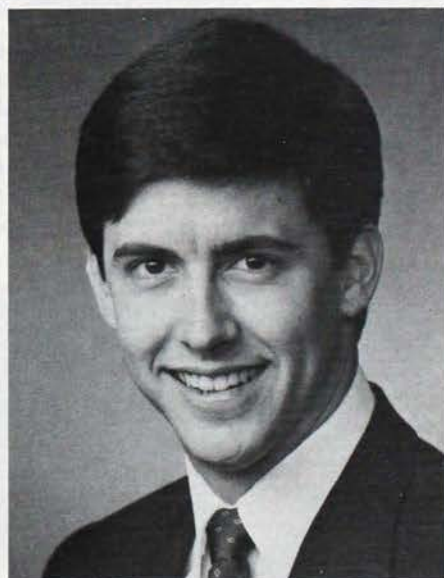
Mike is a 1975 initiate of Alpha

Upsilon Chapter at Miami University in Oxford and served the chapter as Vice President for Pledge Education. He joined the staff of The Central Office in March, 1978, as a Chapter Consultant, a position which he held until July, 1980. He rejoined the staff in April, 1981, in a newly created permanent position and, in June, 1981, was named Assistant Executive Director.

Mike is Past President and State Director of the Oxford Jaycees. He and his wife, Carolyn, who is an alumnus of Theta Phi Chapter at the University of South Florida, reside in Oxford with their two sons, Patrick and Kevin.

C. Dean Ferguson serves Delta Sigma Pi as Director of Chapter Services and is responsible for the administration of a host of service programs for chapters and individual collegiate and alumni members. He supervises the Chapter Consultant program, the Chapter Efficiency Index and administers the awards program. Dean works closely with groups pursuing a chapter charter in order to coordinate all expansion or reactivation efforts.

Dean's fraternal activities have been extensive since his initiation as a member of Kappa Chapter at Georgia State University in December of 1977. He served his chapter as Secretary, Vice President for Pledge Education and was his chap-

ter's candidate for Collegian of the Year 1979.

After receiving his Bachelor of Business Administration degree in 1979, he joined Carolina Freight Carrier's Corporation in Charlotte, North Carolina, as a management trainee. He returned to Georgia State University and received a Master of Business Administration degree in June, 1982. During this period, until his relocation to Oxford, Dean was employed as a Customer Service Representative for Sears Roebuck and Company.

Dean, who joined the staff of The Central Office in June, 1984, is a resident of Oxford, Ohio. He is a member of the Oxford Jaycees and enjoys tennis and softball in his leisure time.

One of the most important services of the national fraternity is the Chapter Consultant program. These staff members are generally hired for a period of two years and, during the academic year, spend approximately 50% of their time away from Oxford counseling collegiate and alumni chapters fraternity-wide. It is a very formidable occupation since they frequently move from city to city often on a daily basis and devote an average of 14 hours per day, including most weekends, to their responsibilities. While not traveling during the academic year, the Chapter Consultants perform

various administrative duties.

Beginning his second year as Chapter Consultant is Mitchell B. Simmons. Mitch joined the staff of The Central Office in June, 1985, as Chapter Consultant and is a 1985 graduate of the College of Business Administration at the University of Southern Mississippi. Mitch, an alumnus of Gamma Tau Chapter, majored in Banking and Finance with a concentration in Accounting. He was named to the President's List and the Dean's List and for two years served as a Student Representative of the Business Students Advisory Council and held the office of President of that group.

While a collegiate member of Delta Sigma Pi, Mitch held the offices of President (two terms), Senior Vice President, Chancellor, Ritual Chairman and Pledge Class President. He was also elected as the chapter's delegate to the 34th Grand Chapter Congress in Denver, Colorado. In addition, he was named the Gamma Tau Chapter Collegiate Member of the Year in 1984, the chapter's "Man of Commerce" in 1985 and the Gamma Tau Chapter Alumnus of the Year in 1986.

Originally from Magnolia, Mississippi, Mitch now resides in Oxford, Ohio. He has already visited several chapters this year and has been in attendance at many Regional Conferences this fall.

The staff described for you to this point are the executive staff members of The Central Office. These staff members could accomplish nothing without the dedicated support of the administrative staff members. In her 29th year of service to Delta Sigma Pi is **Viola T. "Peg" Donovan**. Her major responsibility is the processing of the Chapter Efficiency Index. During a given year, she will handle in excess of 20,000 individual requests for CEI point recognition. Although the record keeping functions of the CEI have been computerized, Peg still must review many requests in detail. This is quite a task especially during peak deadline periods. She also serves as one of the receptionists for The Central Office.

Joining the staff in 1965, **Beverly J. Norris** is the receptionist and also one of the secretaries at The Central Office. She processes all District Director appointments and prepares other reports for national officers and the staff at The Central Office. She processes all Regional Director addresses and prepares other reports for the members of the Board of Directors.

Marjorie J. Wisecup has been on the staff since 1973 and currently serves as the bookkeeper. She handles all financial record keeping functions and prepares many reports for both internal and governmental needs.

Sharon R. Bourne joined the staff in 1978 and handles all bookkeeping for the National Endowment Fund. In addition, she also processes all orders for merchandise, chapter supplies, jewelry and District Director supplies.

Constance J. Biggs served as a member of The Central Office staff from 1978 until April of this year when she took maternity leave. Coni rejoined the staff on a part-time basis in October and currently serves as Executive Director Mazur's Administrative Assistant. Coni processes all faculty and honorary initiate applica-

tions as well as all student loan information. She prepares several reports for the staff and members of the Board of Directors and also handles some correspondence. She also assists Executive Director Mazur with the CompuServe information service and The Deltasig Bulletin Board system.

Joan Howe began part-time employment in 1981 and, in 1982, became a full-time employee. Joan is the computer system operator and is also responsible for membership records. She processes in excess of 4,000 new members and greater than 20,000 address changes each year. Joan also processes the general mailings to chapters, national officers and individual members that are sent each year. In addition, she generates the dues printouts and fills general membership label and printout requests.

In January of this year, **Hilda Krueger** joined the staff as a secretary. Since April, she has also been responsible for the regalia system, including regalia reservations. She also prepares all membership and Life Membership certificates and is involved in the preparation of some correspondence and reports.

Donna Amrhein joined the staff in June of this year as a secretary and is responsible for the preparation of correspondence, reports and the typing of some publications. In addition, she has reorganized the filing system at The Central Office and has shared filing duties with **Cindy Dykes**, who joined the staff in September of this year as a part-time employee. Cindy prints most of the general mailings sent to chapters and many of the publications released by the national fraternity. She is also responsible for the filing of all correspondence in The Central Office.

As with any other office facility, The Central Office requires regular maintenance. Since 1968, **Winford Combs** has served as building custodian for The Central Office. Winford is a part-time employee who is employed on a full-time basis at Miami University.

We have introduced or, in many cases, reintroduced you to members of the staff of The Central Office in Oxford. We often hear comments, both positive and negative, about

in the fraternity each year. Chapter Consultants are recent graduates, trained in all areas of chapter operations, who offer suggestions to chapters concerning their programming. The first Field Secretary or Chapter Consultant was Charles L. Farrar who was hired in 1959. Since 1959, 27 men have served anywhere from one to three years in the position of Chapter Consultant providing consultation services to collegiate and alumni chapters.

As Delta Sigma Pi continued to grow, a need for more space in The Central Office was evident. In 1970, two wings were added to The Central Office Building approximately doubling the size of the national headquarters. These additions provided office space for the Chapter Consultants, a separate membership records room, a separate financial records room and a mail room. It also provided for more storage space, a Board of Directors Room and an Archives Room.

In 1981, in an effort to provide even more service to collegiate and alumni chapters, the fraternity approved the creation of an additional staff position, the Director of Chapter Services. Mark A. Roberts was the first Director. Mark A.

Roberts was hired for that position and since then the fraternity has tried to provide a stronger emphasis in the area of chapter services.

Throughout the years, The Central Office has tried to maintain the latest in office machines and products. It utilizes the latest in word and data processing equipment and has done so since 1982 when the fraternity purchased its own computer system and in 1985 when it added a full line of word processing capability.

Since The Central Office was moved to Oxford 30 years ago, the fraternity has employed four Executive Directors, six Assistant Executive Directors, two Director of Chapter Services and 27 Chapter Consultants. In addition, several valuable clerical and maintenance personnel have worked for the fraternity.

The Central Office has come a long way since 1956 when it moved to Oxford, Ohio. The Central Office has grown to include 12 full-time and three part-time employees, has doubled in physical size and continues to be one of the most attractive national fraternity headquarters in the world. Delta Sigma Pi continues to remain a progressive and dynamic fraternity and its attributes have been reflected in its national headquarters, The Central Office, in Oxford for 30 years.

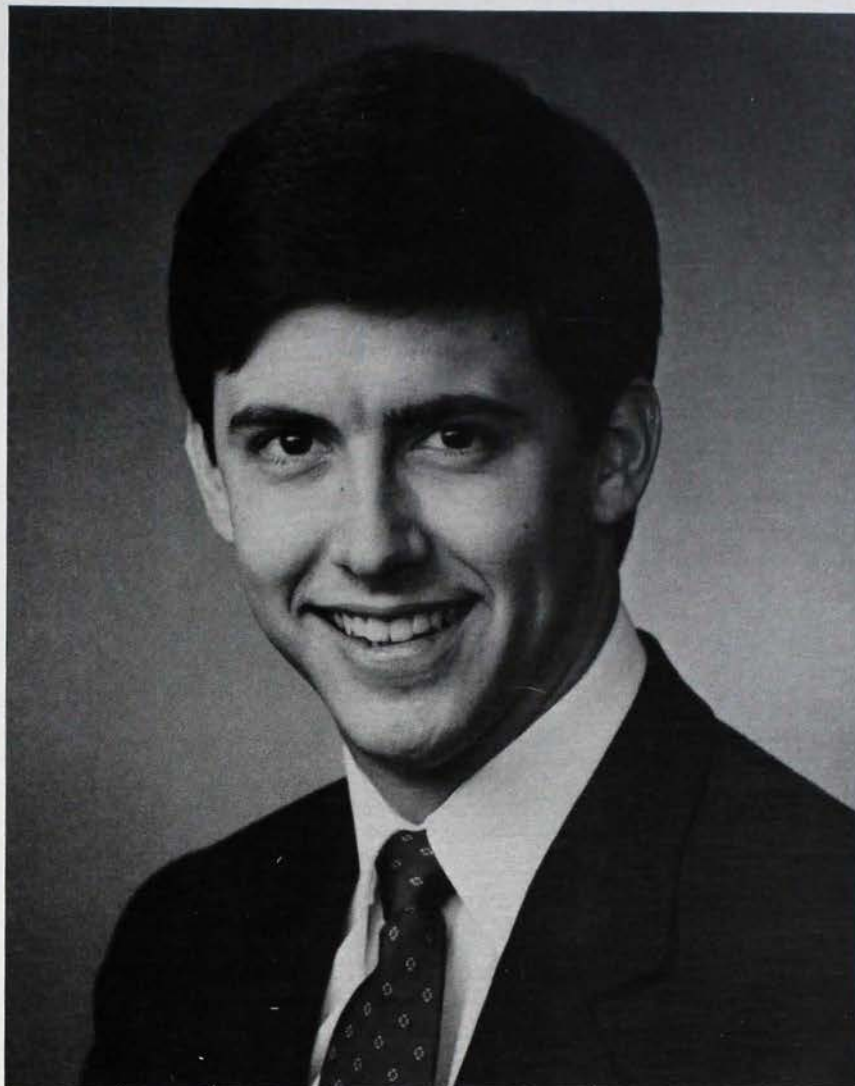
