## INTERNATIONAL FRATERNITY OF DELTA SIGMA PI, INC. MINUTES SOUTH CENTRAL PROVINCIAL COUNCIL MEETING MARCH 19, 2022 VIRTUAL

The South Central Provincial Council Meeting of the International Fraternity of Delta Sigma Pi, Inc. was called to order according to Ritual at 10:05 a.m. CST on Saturday, March 19, 2022, by Interim South Central Provincial Vice President Henry McDaniel online via Zoom.

At this time, McDaniel relinquished the chair to Chancellor Allen, who introduced Nominations Chair and Caucus Moderator Smith; Nominations Committee Members Aimee King, Kathy Jahnke, and Kevin Gore; Secretary Stockbridge, and Credentials Chair Brodbeck. Brodbeck then conducted the Roll Call of Delegates and announced 41 delegates present with 43 eligible to vote. **See Addendum A.** 

Gulf South Regional Vice President then moved to adopt the Agenda, as amended. The motion was seconded by Theta Omega and unanimously adopted (35/0).

Red Stick Alumni Chapter moved to dispense with the reading of the minutes of the 2022 South Central Provincial Council Meeting and to approve the minutes as previously distributed. The motion was seconded by Eta Theta and unanimously approved (39/0).

There were no votes taken since the last council meeting.

## **OLD & NEW BUSINESS**

Chancellor Allen then noted there was no old business and moved into new business.

Chancellor Allen recognized Caucus Moderator Smith, who opened the Provincial Vice President Election Caucus at 10:21 a.m. CST.

Caucus Moderator Smith then recognized Brother Marquis Allen who introduced Candidate Allan Schuster.

Caucus Moderator Smith then recognized Candidate Schuster who delivered his candidate speech with 30 seconds remaining.

Caucus Moderator Smith then opened the floor for a 30 second period of Question & Answer.

Caucus Moderator Smith announced no questions on the floor.

Caucus Moderator Smith then recognized Brother Rene Pena who introduced Candidate Gilbert Landras.

Caucus Moderator Smith then recognized Candidate Landras who delivered their candidate speech with no time remaining.

Caucus Moderator Smith then recognized Brother Emily Kepley who introduced Candidate Henry McDaniel.

Caucus Moderator Smith then recognized Candidate McDaniel who delivered his candidate speech with 45 seconds remaining.

Caucus Moderator Smith then opened the floor for a 45 second period of Question & Answer.

Caucus Moderator Smith then recognized Tornado Alley RVP; McDaniel answered.

Caucus Moderator Smith then opened the floor for a 10 minute period of Question & Answer.

Caucus Moderator Smith then recognized Tornado Alley RVP who addressed all candidates; McDaniel, Landras, & Schuster answered.

Caucus Moderator Smith then recognized St. Louis Alumni Chapter who addressed Candidate Landras; Landras answered.

Caucus Moderator Smith then recognized Midwestern RVP who addressed all candidates; Landras, Schuster, & McDaniel answered.

Caucus Moderator Smith concluded the Question & Answer period.

Caucus Moderator Smith announced that all candidates will act as their own tellers for the election; voting will remain open for 5 minutes.

Caucus Moderator Smith requested a voting delegate count from Credentials Chair Brodbeck who announced 37 credentialed delegates eligible to vote (44 credentialed delegates, 7 being RVP/PVP and thus ineligible to vote in election per policy).

Caucus Moderator Smith then yielded the floor back to Chancellor Allen who called to open voting for the South Central Provincial Vice President election at 11:24 a.m. CST.

Chancellor Allen called to close voting at 11:30 a.m. CST.

Chancellor Allen announced Candidate McDaniel as the newly elected South Central PVP.

Chancellor Allen thanked leadership team, candidates, and delegates for their participation in the meeting.

Chancellor Allen yielded the floor to Past Grand President and Nominations Chair Smith to install South Central Provincial Vice President Elect McDaniel according to Ritual.
